## Hello Andrew,

From an Environmental Health perspective there is no objection to the proposal but would like the following to be considered.

- 1. Existing roof and façade materials are described in the application as "Corrugated cement fibre sheeting". A full asbestos survey should be carried out on the existing structure <u>before</u> works commence to determine if ACM's are present. Any identified ACM's must then be handled and disposed of appropriately by a licensed and authorised person.
- 2. Section 20 of the application "Hours of Opening" (operation) has not been completed. Confirmation of operating hours should be ascertained and determined, including intended vehicle movement times to minimise disturbances to noise sensitive premises.
- 3. Consideration should be given to noise and odour abatement measures to all machinery and plant so as to minimise the potential for Statutory Nuisance to nearby sensitive premises.
