Council of the Isles of Scilly Council Tax Increased by 4.99% (Council Tax Band D Equivalent)

The proportion of your bill that covers the services provided by the Council of the Isles of Scilly will increase for 2025/26 by 4.99%.

The overall increase for 2025/26 includes the requirement of the Devon & Cornwall Police and Crime Commissioner which increased its proportion of council tax by 4.99%. The combination of these two precepts results in an overall Band D net increase of 4.99%

Council Tax Precepts and Levies

In addition to the precept for Devon & Cornwall Police the Council is required to pay sums to two other bodies known as levies from the council tax. These bodies and the sums they have levied are as follows:

- Isles of Scilly Inshore Fisheries and Conservation Authority £39,723 to support the work they complete under the Marine and Coastal Access Act 2009
- Environment Agency £2,965 for Flood and Coastal Erosion Risk Management Levy

Council Tax Cost to You

The table below shows you how much you will pay for the Council of the Isles of Scilly council tax and that required for the Devon and Cornwall Police & Crime Commissioner.

Most dwellings, whether rented or owned, are subject to council tax. Each dwelling has been allocated one of eight bands by the Valuation Office. Your Council Tax bill states which band applies to your dwelling.
