Isles of Scilly Area of Outstanding Natural Beauty

(AONB) Partnership Delivery Funds

This form is to express your organisations interest in the Isles of Scilly Area of Outstanding Natural Beauty (AONB) Delivery Funds.

Applicants should note that the grant-in-aid attached to this expressions of interest process is offered on a not-for-profit basis, with the expectation that any profits, which might arise from any of the activities associated with the grant funding, will be absorbed into agreed AONB activities.

Section 1 - Background Information

The Council of the Isles of Scilly receives an annual grant from Defra (Department for the Environment, Food and Rural Affairs) to deliver aspects of the AONB Management Plan on behalf of the AONB Partnership.

The AONB Management Plan sets the strategic direction for the conservation and enhancement of the AONB landscape and its special qualities. The AONB Partnership is made up of the Council of the Isles of Scilly, Tresco Estate, the Duchy of Cornwall, the Isles of Scilly Wildlife Trust, the Islands' Partnership and the Isles of Scilly Farmers' and Growers' Initiative.

The Council of the Isles of Scilly wishes to transfer the delivery aspect of the AONB Unit to a third party organisation to make AONB delivery more focussed and targeted towards delivery of actions from the AONB Management Plan.

The overall aim is to ensure that the AONB Partnership delivers against AONB Management Plan objectives, and in doing so, retains best value for money from the grants it receives.

The organisation taking on AONB Delivery will need to ensure the following is delivered:

- Ensure that the AONB Partnership's mission is incorporated into the receiving organisation's mission to ensure the two are aligned;
- Ensure that actions for delivery are aligned to AONB Management Plan Objectives.

The Council of the Isles of Scilly has a grant funding agreement in place with Defra until 31st March 2016, therefore this Expression of Interest, and receipt of grant-in-aid from the Council, will run up until that point. The agreement could look to be renewed should Defra issue further funding, or the AONB Partnership is able to secure funding from alternative sources and the Council is deemed to be the host of that funding.

The amount of funding available in 14/15 is £62,000

The amount of funding available in 15/16 is £100,000 (subject to the final award made by Defra)

All of the received expressions of interest will be reviewed by the Council of the Isles of Scilly and the Chair of the AONB Partnership. A decision will be made on the proposal that best fits the aims and objectives of the AONB Management Plan in the week commencing 6th October.

Once a preferred submission has been identified, the Council will meet with the proposer to conclude the Grant In Aid Agreement document. The expression of interest submission will be appended to the Grant In Aid Agreement and will therefore be part of the contract between the parties.

Completion of the Grant In Aid agreement will trigger the release of the funding to the appointee.
