1. Local Connection

2.1 Homeless and accepted by the Council, in priority need, unintentionally.	25 Points
2.2 Homeless and deemed as eligible/priority need but the causation is intentional	10 Points
2.3 Homeless and not in priority need intentionally or unintentionally	10 Points
2.4 Those who are homeless and require urgent re- housing as a result of violence or threats of violence, including intimidated witnesses, and those escaping serious anti-social behaviour or domestic violence	30 Points

4. Accommodation Facilities & Condition of Property

4.1 For each amenity lacking	5 Points	
4.2 5 Points will be awarded for each failure to meet a satisfactory standard (eg leaking roof, dampness, lack of drainage, electrical wiring, unsafe accommodation for those who occupy it) to a maximum of 30 points, as assessed by the Environmental Health Officer.	5 Points	
4.3 Immediate hazard within the property as identified by the Environmental Health Officer	15 Points	

5. Overcrowding

6.1 10 Points will be awarded for statutory overcrowding	
6.2 5 points will be awarded if your current accommodation does not meet	
the Councils ideal standard for accommodation for a household make up of	
your size.

deterioration in their medical condition)	
8.2 For medium priority (ie current accommodation is	20 Points
causing substantial difficulty with their medical condition)	
8.3 For low priority (ie current accommodation is causing	15 Points
some difficulty with their medical condition)	
8.4 Those who need to move urgently because of life	40 Points
threatening illness or sudden disability	

9. Social and Discretionary

9.1 A Social Services referral based on welfare/social	10 Points	
9.2 Those who need to move to a particular locality in the district of the housing authority, where failure to meet that need would cause hardship (to themselves or others) as evidence by a professional working with this applicant (Dr, Social Services, Police etc)	15 Points	

10. Social and Economic

10.1 Persons in receipt of Job Seekers Allowance, Income Support, Disability Living Allowance, Disability Working Allowance or Working Families Tax Credit.	10 Points	
10.2 Persons with a low income to be assessed by the Housing Benefit Officer on the minimum rent based on the indicative rent levels.	10 Points	
10.3 Persons in employment in the islands	5 Points	

Only one of the above sections will be awarded. If an applicant meets the requirements for one or more the one with the higher points will be awarded.

11. Armed Forces

11.1 (a) former members of the Armed Forces	10 Points	-
11.2 serving members of the Armed Forces who need to	10 Points	-
move because of a serious injury, medical condition or		
disability sustained as a result of their service.		
11.3 bereaved spouses and civil partners of members of the	5 Points	
Armed Forces leaving Services Family Accommodation		
following the death of their spouse or partner		
11.4 serving or former members of the Reserve Forces who	5 Points	
need to move because of a serious injury, medical condition		
or disability sustained as a result of their service		

12. Transfer assessment ONLY

12.1 10 Points will be awarded for each bedroom lacking in an	
overcrowded situation and 10 Points for each bedroom in excess of	
household requirements in an under occupation situation.	
12.2 10 Points will be awarded per qualifying medical, welfare or social	
economic grounds as per the housing register.
