The location(s) in which I wish to trade is (are):

Porthcressa Grass- adjacent to the library, on the area of the grass on the corner of the Dibble and Grub end of the beach, as indicated on the blue circle on the map below. In previous years there has been a container on this area hiring out sea Kayaks during the summer season.

I would like to trade from any of the grass areas adjacent to Porthcressa beach; but ideally on the grassed area as indicated above.

If situated on one of the grassed areas I will not be causing any disruption to the main walkways beside Porthcressa beach- nor will I be on any highways.

I do hope you will look favourably on this as my intention is to assist the local economy by ensuring that visitors to Porthcressa have access to refreshments whilst enjoying their time on the beach.

I know that this venture would be particularly useful for day trippers in the summer who enjoy spending time on Porthcressa. If visitors knew that there was an option for them to stay on the beach, enjoying the sunshine and having access to refreshments, I am in no doubt that this would encourage them to return year after year, as they wouldn't have to worry about bringing a picnic across on the ferry.

I know that the local economy relies on tourism and my aim is to give tourists and locals alike, an affordable option to enjoy food and drink in the sunshine, encouraging more people to the area.

The horsebox could be stationary if permission was granted for it to remain in position throughout the season. However, I am equally as happy to site the vehicle at the beginning of the day and remove at the end of the day. I would happily supply the matting to ensure that the chance of damage to any grassed areas in the daily siting of the vehicle was minimized. I would be moving the horsebox with my own car- a VW Tiguan. My car is fully taxed and insured and has a valid MOT, it is in good condition. The horsebox I will purchase will also be in very good condition.

How we will use the information about you? The Council has a general discretion to grant street trading consent.
