I just wanted to send a quick email around the island to let everyone know that we – Island Fish will (fingers crossed) be putting in planning permission next week to build workspace for the business at Kenython.

As you know we have worked out of Newpark for the last two years and although this has worked well working out of my home presents a number of challenges – it doesn't make for efficient working meaning that simple tasks take twice as long as they should, it means we can't grow the business any more than we have at present but more critically the impact on family life is pretty significant – and my house smells!!!

Over the last year we have looked at a number of sites where we could build workspace and because of a number of limitations, not least we have to build wherever we can plug into available power (our only two options Kenython and building at Quay) we have after discussions with the Duchy decided to develop at Kenython. This site also has the added advantage of being close to Bar meaning we do not have to lug baskets of fish and shellfish through town as well as being close to our store field across the road.

In simple terms our intention is to move lock stock and barrel what we do now to a more efficient building, demolishing what is there are present as it is not fit for purpose and building pretty much like for like - a single storey square building on the same footprint as there is at present. The building if we receive planning permission will allow us to have the following: a dedicated raw fish filleting room, a cooking room and a crab picking room. The space will also include a small office, toilet and shop area similar to what we have now. To reiterate we do not intend to do anything more than what we do now - quite simply we are desperate for work space that will allow us to work more efficiently, providing critical space for a cold room, and a range of gadgets that will to a degree mechanise the tedious process of picking crab. If successful in our application we would also commit to maintaining the garden as is, we recognise that locals and visitors alike enjoy the garden at Kenython and would definitely look to maintain and add to this feature of Bryher. We would also look to maintain the hedges – it is important to us that this building and the area around it is an attractive and inviting space.

I know some people may be concerned about the loss of residential bed space, however the Duchy of Cornwall is in the process of drawing up plans to replace the bed space lost by Kenython with a new build so that Bryher retains the same number of bed spaces available to residents. I'm sure they will provide more details in the fullness of time.

We – Mark, Mike, Sue, Andy and I did want to let you know what we intended to do ourselves so that there was no confusion on what we were planning. When we started Island Fish two years ago building something for the next generation was key to our plans, having workspace is critical for this to happen.

Your support to help us secure planning permission would be most appreciated. Hopefully you feel that over the last two years we have added to what Bryher offers and if you feel you could pen a letters of support for our venture so that we could include this in our planning application (deadline 12<sup>th</sup> October) we would be most grateful. If you would like to chat about out plans or look at what we propose do give me a call.


