4 - Relating to the boundary wall at Lemon Hall and the failure of the adjoining neighbours to engage with the Party Wall process means that it is unreasonable for this to be made a pre commencement condition. We acknowledge that this wall is part of the Listed Building curtilage however the significance of this wall is minor and not specifically mentioned within the buildings listing.
We do not feel that the Council of the Isles of Scilly has worked with us in a positive and proactive manner as set out in the Statement of Positive Engagement and instead has placed unreasonable obstacles in the path of this much needed development of affordable housing, which already had a valid planning consent. We feel that we have been disadvantaged by the Council's actions which appear to have been influenced by the Council's fear of legal challenges from the neighbouring occupiers rather than on a balanced consideration of the merits of this scheme.
