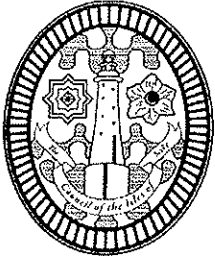

Site and particulars of development: Harbourside Hotel, The Quay, St Mary's
Amendments to planning permission P/12/087 including revised fire escape staircase, installation of window at ground and first floor levels on South gable end, re-position first floor double doors on East facing balcony, replacement of 4 no. windows on West elevation with one single window.

In pursuance of their powers under the above act, the Council hereby PERMIT the above development to be carried out in accordance with the following conditions:

- C1 The development hereby permitted shall be begun before the expiration of 3 years from the date of this permission.**

Reason: In accordance with the requirements of Section 91 of the Town and Country Planning Act 1990 (as amended by Section 51 of the Planning and Compulsory Purchase Act 2004).

- C2 The development hereby permitted shall be carried out in complete accordance with the details shown on the approved submitted plans numbered 'T1033268.06 rev A' and 'T1033268.04 rev A' stamped and dated 19th August 2014.**

Reason: To define the nature and extent of the development in accordance with Circular 11/95 and for the avoidance of doubt.

- C3 All works involving machinery required in connection with the implementation of this permission shall be restricted to between 0800 to 1800 hours Monday to Saturdays. There shall be no works involving machinery on a Sunday, Bank or Public Holiday.**

Reason: In the interests of protecting the residential amenities of neighbouring properties.

- C4** The conditions attached to and specified upon the decision notices for planning permission references P/12/087 & P/13/040 relating to these works are reiterated and still in force insofar as they have not already been superseded or discharged to the satisfaction of the Local Planning Authority.

Reason: For the avoidance of doubt.


1 Statement of Positive Engagement
