Dear Mr Dryden,

As part of the continuous communication requested in respect of proposals for the compliance with condition C5 of P/14/026 FUL and condition C4 of P/14/027 FUL we can advise as follows:

- To the top of the stone boundary wall we shall cap off the tops with a lime based concrete (NHL5).
- Stone walls, all joints will be hacked out to a firm base and re-pointed with a lime mortar NHL3.5 lime and left with a churn brush finish.
- The existing blockwork gable end, the top part will be removed to wall plate level and will receive a cement and sand capping.

We are maintaining a constant dialogue with the Contractor and should there be any variance from these proposals or further design detail available we shall keep you informed.

We trust this is sufficient to continue works, if not please advise and we shall endeavour to address any concerns.
