# **Description of site and development:**

This is a notification to carry out tree works in a conservation area. Specifically the work include the trimming back and re-pollarding of trees along the western boundary and crown lifting trees along the southern boundary. The trees are growing around the Porthmellon Enterprise Centre.

The trees are Elm Trees growing along the western boundary with Moorwell Lane and require repollarding back to previous pollarding points. Along the southern boundary adjacent to Scilly Cart Co the trees are to be crown-lifted to create raised and re-balanced crowns that remove interference with work areas and buildings.

Conservation Area, AONB, Heritage Coast and close to the Lower Moors SSSI

#### Appraisal/key issues and conclusion:

The trees in question form and important boundary between the residential area of Jacksons Hill and the Industrial Estate and the Industrial Estate and the Waste Site as well as the SSSI at Lower Moors to the South. It is therefore important to retain trees particularly around such an industrial part of teh Conservation Area.

The works, however will retain appropriate hedgerow boundaries and keep the trees in check where they are growing in close proximity to the industrial buildings. The trees have limited amenity value but as identified above are nonetheless an important part of both the screening and biodiversity links around the industrial estate.

The works are overall considered to be appropriate and it is recommended that no objections are raised.
