SUPPORTING STATEMENT

We are hoping to move the boat hire element of our business out of our current Boatyard to the area at the top of the beach at Green Bay, just in front of the Boatyard. We would like to purchase a bespoke small wooden hut where we could get our customers ready to go out on the water and meet them when they return. We are hoping that the location next to the footpath will enable us to attract more passing trade and the vantage point at the top of the beach would ensure the optimum safety of our customers as we would be able to watch them out on the water in Green Bay.

We are applying to change the use of a small part of land that falls just outside our Boatyard. The land is owned by the Isles of Scilly Wildlife Trust who have kindly given their support to our project. The land is not being used for any purpose at present and we would like to site a seasonal boat hire hut there on a temporary basis.

We will be mounting the hut on a trailer to enable us to move the hut in and out of the yard as necessary. When the hut is back inside the Boatyard the land will look just as it does now. We do not need to make any alterations or additions to the area. The boat hire business is seasonal and very weather dependant. The hut will only be in situ when we are able to offer boat hire and has been designed for us to be able to easily manoeuvre with our tractor.

If successful, we will purchase a solar panel to give power to the hut so do not need to run cables to the site. The area is one that we love, just at the top of one of our favourite beaches, so we are mindful of the appearance and the need to design something sympathetic to the area. With that in my mind, we have worked to create a bespoke design that will fit into the land as it currently lies. It will not affect or encroach on to the footpath that runs past.

The location of the hut will not increase the footfall to the area or the amount of noise generated- the new location is just across the path from our current Boatyard where our customers already visit.
