- C2 The development hereby permitted shall be carried out in accordance with the approved details only including:
 - Site Location Plan
 - Velux GPL MK 10 2070 Pine Top-Hung Window 78x160cm Specification Sheet
 - Proposed West Elevation, Drawing No: J-AM-2A. Date Stamped as received 12 Jul 2018 These are stamped as approved.

Reason: For the clarity and avoidance of doubt and in the interests of the character and appearance of the Conservation Area, Area of Outstanding Natural Beauty and Heritage Coast in accordance with Policy 1 of the Isles of Scilly Local Plan 2005.

- C3 The development hereby permitted shall take place in accordance with the following reasonable bat avoidance and mitigation measures:
 - ensure all workers (including sub-contractors) on site are familiar with bat legislation and agree to work within best practice measures, with respect to bats;
 - carry out careful checks under any tiles of the roof when being removed, checking continually for bats, ceasing works should any bat be discovered and following the

- guidance set out in the informative (2) below; and
- retaining an existing roof vent and not restricting its use for bats, during the course of the works; and
- Operational activities should be careful not to disturb bats around the known roost site and existing bat boxes that exist at this property.

Reason: To minimise the impact of the development and to safeguard bats and their roosts which are specifically protected by law.

Further Information

- 1. In dealing with this application, the Council of the Isles of Scilly has actively sought to work with the applicants in a positive and proactive manner, in accordance with paragraph 38 the National Planning Policy Framework 2018.
- 2. The Applicant is reminded of the provisions of the Wildlife and Countryside Act 1981 and the E.C. Conservation (Natural Habitats) Regulations Act 1994, the Habitat and Species Regulations 2012 and our Natural and Environment and Rural Communities biodiversity duty. This planning permission does not absolve the applicant from complying with the relevant law protecting species, including obtaining and complying with the terms and conditions of any licences required, as described in part IV B of Circular 06/2005. Care should be taken during the work and if bats are discovered, they should not be handled, work must stop immediately and a bat warden contacted. Ideally works should take place outside the main breeding and mating season of common pipistrelle bats. The works should therefore be carried out after the 1st November and before 1st May inclusive, to minimise impacts

Extra care should be taken during the work, especially when alterations are carried out to buildings if fascia boards are removed as roosting bats could be found in these areas. If bats are found to be present during work, they must not be handled. Work must stop immediately and advice sought from licensed bat wardens. Call The Bat Conservation Trust's National Bat Helpline on 0845 1300 228 or Natural England (01872 245045) for advice.

3. The applicant is reminded that there may be a need to comply separately with the Building Regulations for the works, hereby approved. This permission does not confirm any building works as compliant with the Building Regulations.
