# **Site Description and Proposed Development**

TheWorkshop in the Thoroughfare is currently an empty workshop building with a groundfloor workshop area and storage space within the roofspace. It was last used as a workshop and retail area known as the Chandlery. The building currently remains vacant but the applicant proposes a pedestrian access door on the west gable elevation on the ground floor, in place of an existing window. This

is proposed to provide an alternative means of access to the storage element of the ground floor, separate to the main access to the building.
