As requested, we have now completed the table that you sent. Hope this is ok.

Holy Vale Farm size: 1.8495(ha) 4.57acres Nature of Agricultural Activities: Permanent Grass Pasture, which includes ponds, scrapes and drainage ditches to comply with the HLS requirements. Leaseholder: John & Kay Banfield Leaseholder Address: Middle Tinks Cottage, Holy Vale, St Mary's, Isles of Scilly, TR21 ONT Lease Period: 20 Years Rationale for New Agricultural Building: The current Polytunnel which is being used for storage of equipment, tools and as a workshop is not large enough, nor secure enough, for the machinery required to manage the landholding that we currently have. The size of landholding may be deemed "small" but regardless of size the machinery required to maintain the land and meet the HLS requirements is still the same as a larger holding. In coming years' we will likely be carrying out major tree management/work (in line with regulations and legislation) to enhance the area and improve the health of the Elm trees - having all the required equipment and facilities accessible and on site will enable this work to be carried out more easily. Notwithstanding the potential imminent sale of the campsite and the fact that any tools/machinery currently stored there will need to be moved on and stored elsewhere for security and maintenance reasons; consequently it makes sense to have them all stored in one location, rather than spread around and potentially incurring additional costs, damage and losses.

Hi Lisa

Please find attached plan which shows the full extent of the tenanted land in question; this does not require a different declaration of ownership.

Currently the machinery is stored as follows:

- Tractor & Front Loader (stored in Polytunnel)
- Topper (stored in Polytunnel)
- Rotavator (stored undercover, offsite)
- Trailors x 2 (1 stored outside in the field bottom left-hand side of the yellow track, 1 stored offsite outside)
- LinkBox x 2 (stored in field next to Polytunnel)
- Digger (stored in field next to Polytunnel)
- Flail (stored undercover offsite)
- Chipper (stored undercover offsite)
- Log Saw (stored undercover offsite)
- Splitter (stored undercover offsite)
- Chainsaws (stored undercover on and offsite)
- Various smaller pieces of equipment and tools (stored undercover both in the Polytunnel and offsite)

We would like all machinery currently stored offsite undercover, in order to protect it from the elements, to be onsite; additionally, the machinery currently stored onsite outside would also be kept inside, in the proposed Polytunnel replacement.

The proposed Polytunnel replacement will not be used for storage of bulbs or crops.

The submitted proposed plan drawing indicated a concrete pad at maximum of 275mm thick will be laid for the building to be constructed on; however, my understanding from talking to the ground works specialist is that for the purposes of this build, it is more likely to be 150mm thick.

Dear Lisa

Many thanks for your email requesting further clarification in relation to the agricultural needs associated with the land in question.

The size of the field in which the replacement building will be situated is just a part of the area of land within John Banfield's agricultural lease, which will be serviced by the building. The agricultural equipment required and stored within the proposed, more secure, building is necessary to ensure this land is maintained appropriately (both to satisfy the Duchy's requirements but also for the benefit of wildlife under the High Level Stewardship Scheme).

The total size of the landholding is 1.849 ha (4.57 acres); this includes a meadow, wetland area and ponds, orchard, terraces, extensive gardens, permissive paths, storm drains and Elm tree/hedgerow boundaries; such a variety of habitats/land types/maintenance expectations requires different equipment and machinery to ensure its effective management.

Larger machinery required (and currently in use in Holy Vale) includes:

- Tractor & Front Loader
- Topper
- Rotavator
- Tractor
- LinkBox
- Digger
- Flail
- Chipper
- Log Saw
- Splitter
- Chainsaws

In addition to this there are various smaller pieces of equipment as well as all of the tools required for maintaining the equipment, along with the spares should something break.

The Polytunnel which is currently in the field does not allow us to store all of the required machinery listed above; it is neither large enough in area nor in height, which means expensive machinery is stored outside in the elements. This is not only bad for the machinery, as it increases the chance of breakages and maintenance required, but it can also look untidy and is not what we want for Holy Vale or the wider scenic beauty of the AONB.

The current Polytunnel is not secure and machinery, tools and equipment stored both in the tunnel and outside (for lack of internal storage space) is easily accessible, and can be tampered with or taken should others feel inclined to do so.

I hope that this information answers all your queries but if you require anything further in relation to the above please do get back to me.
