Reducing the height of 1x Mature Elm, 1x Mature Ash and 1x Pine to prevent shading to the property known as Watermill House and to prevent large falling branches from causing damage to the property and garden. Pollard Elm to 12 ft. Take out the top of a Pine to reduce its height.
Reduce height of Ash and remove overhanging branches causing risk to residential property.
