

PLAN IS TO CARRY OUT A 1/3 CROWN REDUCTION ON T1, T2 AND T3 AND ALSO A CROWN LIFT. THIS WILL GIVE THE REQUIRED CLEARANCE OVER THE HIGHWAY, REDUCE THE LIKLIHOOD OF DAMAGE FROM WINDBLOW AND REDUCE SHADING ON THE SOUTHERLY ROOF IN ORDER TO POTENTIALLY FIT SOLAR PANELS. THE WORKS WILL ALSO LIFT THE LOWER BRANCHES AWAY FROM THE FABRIC OF THE BUILDING. A 1/3 CROWN REDUCTION IS SHOWN ON EMAIL PHOTO FIG. 1.
TREE T4 IS NOW GROWING SO CLOSE TO THE BUILDING AS TO POTENTIALLY CAUSE DAMAGE. PLEASE SEE FIG 2 ON EMAIL. PLAN IS TO REMOVE THIS TREE.
