

Thank you for the further information provided by Mr Jeremy Downing regarding ADB B5 vehicle access for the above planning application.

Paragraph 13.1 in volume 1 of ADB Part B states 'there should be vehicle access for a pump appliance to within 45m of <u>all points</u> within dwellinghouses'., the planning application suggests the proposal will be used for additional sleeping for the dwelling and therefore point 13.1 is not just relevant but important.

The following sentence is taken from the Government website, '**The 45mtr vehicle access is to take account of the actual distance that the firefighters need to carry kit and lay hoses from the vehicle to reach a potential fire'.** Therefore the measurement should be taken from where the pumping appliance would be situated usually on the public highway, a track or similar and then the route a hose would take when being laid on the ground, this would <u>not</u> include over hedges, walls of through one building to get to another building.

When looking at the diagram below provided by Mr Downing it appears to show a straight line from the edge of the development area through the bungalow to the proposed planning development, therefore it's still unclear if 13.1 of ADB Vol 1 [45mtr vehicle access] has been met as suggested by Mr Downing.



As the information provided above is still unclear if the planning authority would like to ensure vehicle access within ADB B5 will be met to assist in their decision making process the fire authority would advise a scaled plan [1:100 or 1:200] clearly showing the distance measured the way a hose would be laid from the pump appliance stationary position on the highway to all parts of the proposed development is submitted for observation.
