**Application to vary Condition C2 of Planning Permission Reference: P/23/086/COU – Temporary use of land as a construction compound with associated welfare facilities to support South West Water upgrade to waste and water infrastructure across the Isles of Scilly for up to four years at Land at Green Waste Processing Site Parting Carn Lane, Parting Carn, St Mary's Isles of Scilly.**

We are writing on behalf of South West Water Limited to submit an application to vary Condition C2 attached to planning permission reference P/23/086/COU. The approved development comprises the temporary use of land as a construction compound with associated welfare facilities to support South West Water upgrade to waste and water infrastructure across the Isles of Scilly for up to four years at Land at Green Waste Processing Site Parting Carn Lane, Parting Carn, St Mary's Isles of Scilly.

Condition C2 states:

**C2:** *'The development hereby permitted shall be carried out in accordance with the approved details only including:*

- *Habitat Regulations Assessment (HRA) Stage(Mitigation and Enhancement)*

South West Water have reviewed the construction programme along with the availability of accommodation on the Isles of Scilly. Due to challenges finding available accommodation, the decision has been made to seek consent, through this variation of condition application, to increase the number of sleeping units at the approved construction compound from 10 to 20. This will increase the number of bed spaces from 20 to 40, to allow sufficient numbers of contractors to stay on the Isles of Scilly to complete the proposed upgrades in line with the programme. The plans stamped as APPROVED under condition C2 include *Proposed Site Layout Plan, drawing number: 107780-PEF-XX-500-D.DR-T-0003 P02* and *Proposed Site Elevations, drawing number: 107780-PEF-XX-500-D.DR-T-0004 P02*. Both of these plans have been updated as version P03 to include the additional 10 sleeping units and are submitted as part of this application.

The additional ancillary site facilities had been sized originally to accommodate 40 people and therefore no alterations are required to the ancillary site facilities, including the canteens and offices etc.

This application requests that the wording of Condition C2 is amended to include the revised revision numbers for:

- Proposed Site Layout Plan, drawing number: 107780-PEF-XX-500-D.DR-T-0003 **P03** and,
- Proposed Site Elevations, drawing number: 107780-PEF-XX-500-D.DR-T-0004 **P03**.
