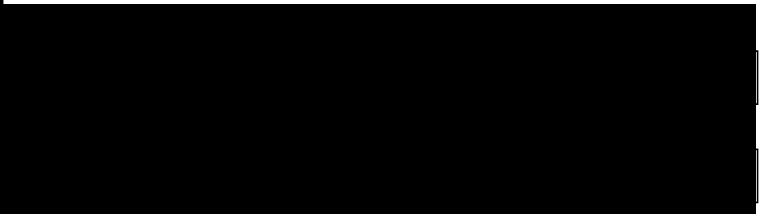

Changes to the internal layout and addition of an Automatic opening vent at the top of the stairwell. Both changes are in order to comply with building regulations requirements. The internal changes consist of the addition of fire protected entrance halls for each apartment (with the exception of the owners accommodation). The AOV at the top of the stairwell does not overlook surrounding properties and is above the eye line when viewed from the top of the stairs. It is designed to open in the event of a fire to allow for smoke to be vented from the stairwell.

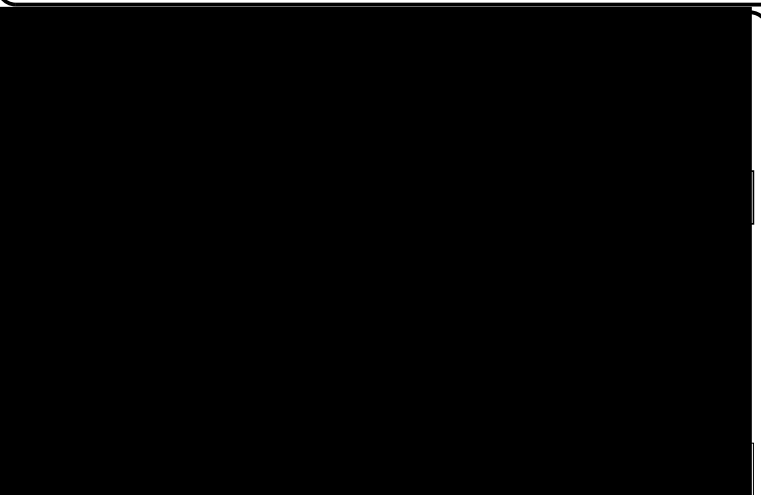
