Proposed materials and finishes: We propose to cover the front elevation and right hand elevation in Cladco 3.6m white smooth finish Fibre Cement cladding board. We would use a timber batten with high load 100mm dpc behind it. A breathable waterproof membrane would then be fitted. At the base of the cladding there will be an insect proof breather which is stainless steel fitted. The product we intend to use as an A1 fire rating, backed by a 10 year guarantee. The board specifications: - Length 3.66m - Width 210mm - Thickness 12mm - Weight (approx) 13.11kg The boards will be installed horizontally.
